Weed Control Why eliminate those uninvited guests

Weed control is an important step in maintaining a healthy lawn and attractive yard. You cannot just close your eyes and wish them away. If you do not take the proper action, not only will they overtake your yard, but they will overtake your neighbors yard as well. Trust me, that will not help your relationship with your neighbors.

Weed control is as simple as identifying the different types plants you have in your yard and taking action to eliminate them. By definition, a weed is a plant that is considered undesirable, unattractive or troublesome. Weeds grow in places they are unwanted. They are plants that let you know when the weather, soil, light or other management programs are wrong. If left unchecked, they will start seeding, spreading and multiplying throughout your yard.

To keep out these pesky invaders, it is important to keep your lawn thick and healthy. Keep your grass blades a little longer. Eliminate any bald spots on your lawn. Finally, make sure you regularly water and fertilize your lawn. You will never completely eliminate all weeds from your yard. It is up to you to decide how many you can withstand.

Overlooking weed control in the rest of the yard is a big mistake. What starts out as a couple of weeds can quickly get out of control. One day you may come home and a sea of yellow flowers or a purple plant may begin creeping across yours and your neighbors lawn (not so pretty). With the proper care, you will not have to worry about your lawn being overtaken by uninvited guests. Your lawn will be thick and beautiful.

To avoid getting a notice from the ARC, you must keep weeds mowed down at all times if you have not eliminated them. Which may mean you will need to mow at least twice a week to be considered a 'properly maintained' lawn. It is the desire if Shadow Wood to maintain a lawn with turf grass. Due to this dry season, clover, dandelions, thistle, crabgrass, and other long grasses have taken over because they thrive in drought conditions. So please water your lawn several times a week. It's all part of maintaining the property values in our community!


